- Surface preparation by Shot Blasting as per grade SA 2 1/2, IS 9954 / ISO 8501/ IS 7285 (Part 2):2017. Three coats of paint shall be applied with minimum thickness of 300 micron. The recommended painting system should be of Category C5–I Very high (Industrial) as specified in the Standard ISO 12944 Part 1 to 8. The proposed Painting system shall conform to Table A 5 of ISO 12944 – 5 Standard.
