



CORRIGENDUM – I

SUBJECT: DISMANTLING, ERECTION, COMMISSIONING & TRANSPORTATION OF CNG COMPRESSOR PACKAGES IN IGL.

This has reference to tender document no. IGL/ET2/CP/CC17451 for the above subject requirement.

The subject tender is modified to the following extent:-

1. The due date of submission of bid is extended till 27.04.2023. Consequently, **clause no. 5.0 – “Details of Bid Documents”** under **Section-I (IFB)** on page no. 7 of the tender document may be read as:

Bid submission due date and time	27.04.2023 at 1430 hrs IST
Bid Submission at	https://petroleum.euniwizarde.com/
Techno-commercial bid opening date and time	27.04.2023 at 1500 hrs IST

2. **Clause no. 11.5 of IFB and 16.10 of ITB** section of the tender document stands modified as below:

PSUs and firms registered as Micro/Small Enterprise with MSME or NSIC are exempted from furnishing Earnest Money Deposit (EMD) / Bid Security, (subject to their enclosing a copy of latest and valid registration certificate for the tendered products/services) with their bid. Declaration as per Annexure-1 to be mandatorily submitted by such bidders with their MSME/NSIC certificate. Traders / Dealers / Distributors / Stockist / Wholesalers are not entitled for exemption of Earnest Money Deposit (EMD) / Bid Security.

“Provision for EMD exemption of MSME bidders who have been reclassified as ‘medium’ enterprise:- Enterprise which have been re-classified as ‘Medium’ enterprise from their earlier status as ‘Micro’ or ‘Small’ enterprise in Udyam registration certificate shall be exempted from submitting EMD. The bidders shall be given this exemption for a period of three years from the date of such upward change in their MSME status. Bidders are required to submit Udyam registration certificate(s) meeting

above stated conditions for exemption under this provision, failing which bid shall be rejected.”

Note: The notification S.O.4926 (E) dated 18.10.2022 is applicable to the upward change took place in the status of Udyam Registered enterprises only for availing the benefits of the schemes as per the policy or guidelines, not on erstwhile Udyog Aadhaar Memorandum(UAM). Any reference to Udyog Aadhaar Memorandum (UAM) certificate shall not be considered for such EMD exemption.”
