In the SoR, there is no line item for motorcycles, which will be a major cost head for all bidders and will have a direct impact on the commercials being proposed by prospective bidder.	Any cost implication like motorcycle, android phones etc. for security resources not explicitly mentioned however envisaged by the vendor for providing services has to be accounted for in the bid price quoted by him accordingly, which means bidder has to provide services of security resources equipped with motorcycle, android phones etc. against the relevant SoR.
