8	Clause - A.9.11 (a) SOR Description		The door shutters shall have bottom rail of 110mm x 60mm and 60mm x 60mm on the rest sides with an additional rebate of 20mm to hold the glass. The overall door opening is 1100mm x 2250mm (W x H). The glass shall be Contraflam Lite 14mm clear 120 min fire rated (EW 120), Non-Wired Toughened Interlayered glass with a light transmission of 87% and a sound reduction of 37 db. The glass shall be compliant to class 181 category of Impact Resistance as per EN 12600. The glass shall be held in its place with the help of minimum 1.6mm GI beading and a special ceramic tape with cross section of 5 x 15mm as per the test evidence. The shutters shall be fixed to the frame using HAFELE/ Dorma SS Ball Bearing Hinges of size 100mm x 75mm and 3mm thickness or equivalent. Beading shall be attached using 4mm x 35mm SS screws at a distance of 250mm c/c (approx) henceforth. The door shall be fitted with Dorma Mortise Sash lock 952F or equivalent and door closer TS 68 of Dorma make or equivalent, Panic Bar double leaf panic exit devices, Panic trim etc. The inactive leaf shall be fixed to the frame using 1200mm long Dorma tower bolt no 9114306 or equivalent.
