It means that two separate Contract Performance Bank Guarantees have to be submitted i.e. one against the Contract which will be equivalent to 2.5% of total contract value initially (which will be a one-time requirement/ one time submission) and second one against the Purchase Orders which will be equivalent to 7.5% of total value of purchase orders released thereafter on 'AS AND WHEN REQUIRED BASIS'.
